BUDGET PERFECT DRIVE TERMS & CONDITIONS

These are the terms and conditions (as of March 22, 1998) of the Perfect Drive program.

Perfect Drive Membership

Customers can enroll in the Perfect Drive program via an enrollment form or at the retail counter. To be eligible to earn points and receive awards in the program, customers must have a Canadian or U.S. mailing address. Each individual must enroll separately and is limited to one membership in the Perfect Drive program. Corporations and other entities may not enroll as members of Perfect Drive. Multiple accounts will be canceled and only the original account number established will be kept on file. Membership in the Perfect Drive program is nontransferable. Once enrolled, members will receive a Perfect Drive membership number allowing them to begin earning points in the program. When enrolling in the program, customers may designate whether they would like to receive Perfect Drive points or frequent traveler miles/credits (e.g. airline miles, frequent hotel rewards) at the time of enrollment. If customers choose to receive frequent traveler miles/credits, they will need to predesignate the specific airline or hotel with which they choose to earn miles/credits. Frequent traveler miles/credits are distributed in accordance with the specific travel programs rules and regulations. If a customer chooses to change their award selection, they must contact Budget at 1-800-BUDGET-4.

Perfect Drive Points

Members must mention their Perfect Drive membership number when making a reservation in order to accumulate points in the Perfect Drive Program. Members will earn one point for every U.S. dollar spent on qualifying rentals at participating locations in the United States and Canada. Points will be converted at a rate of .7 Canadian dollars to 1 U.S. dollar. Qualifying rentals include all vehicle rentals at participating locations. Members may not combine points with other members. Points earned are valid for two years from the end of the calendar year within which they were earned provided the Perfect Drive program is still in existence. Points will not be issued on rentals with the following discount rates: CorpRate accounts not allowed to participate in award programs by contract, government, Budget employee/owner, travel agent, travel industry, tour and wholesale, or if a member chooses to receive credit for a frequent traveler program (i.e., airline frequent flyer, hotel frequency program, etc.). Earned and redeemed points will be reflected on a Perfect Drive statement distributed periodically to members during program participation.

A Perfect Drive Welcome Kit with detailed information on the points needed for each award, the redemption process, redemption form, and Callaway® merchandise brochure will be sent to each member within 3-4 weeks following their third rental transaction in the program.

Perfect Drive Award Fulfillment

A member can redeem specified points for Callaway® Golf merchandise or for Budget Rental Award Certificates. Below are just two examples of the many awards available:

Certificates not combinable.

Standard — Cars (Economy through Full-Size 4-door, VIP Pickup).

In the U.S., peak season dates in 1998 are: April 9-12, May 22-25, July 2-4, November 25-28, December 19-31. In Canada, peak season dates in 1998 are: July 30-August 3, September 3-7, October 8-12, December 23-31. Additional rental awards are available for standard vehicles. An awards brochure detailing all awards will be sent to members in the Perfect Drive Welcome Kit.

To redeem points a member can mail the redemption form to the Perfect Drive Customer Service Center at P.O. Box 1800, Station "D", Etobicoke, Ontario M9A 5C5. Members should allow 3-4 weeks from date award redemption is processed to delivery date of award. Members will be notified of any delays in fulfillment by mail or phone. Once issued, Budget Rental Award Certificates are valid for one year from the date of issue. All awards will only be mailed to the Perfect Drive member at the address on file. All Callaway® Golf awards are subject to availability.

Perfect Drive Award Usage

To use a Budget Rental Award Certificate, advance reservations are required and must be made directly through the Budget Reservation Center by Calling in Canada 1-800-268-8900, or by calling the local reservations number. The BCD# printed on the Award Certificate must be mentioned at time of reservation. Award Certificates may only be used at participating Canada and U.S. Budget locations, and will be subject to vehicle availability. The Award Certificate must be surrendered at time of rental. Vehicle must be returned to renting location except as otherwise permitted. Award Certificates apply to contracted time and mileage only. Members are responsible for refueling services, taxes, excess mileage charges if applicable, vehicle license fees if applicable, surcharges, airport concession fees, LDW and optional terms. Award Certificates are not replaceable or redeemable for cash and are only transferable to a member's spouse. Altered or photocopied Award Certificates will not be honored. Only one Award Certificate can be used per transaction. Budget and all companies affiliated with the Perfect Drive program are not responsible for Award Certificates, correspondence or materials which are lost, mutilated, or delayed in the mail. Award Certificates are not valid at any time for Jaguar, Infiniti, Mercedes or other high end luxury vehicles, 15 passenger van, one-way car or one-way truck rentals. Award Certificates may not be combined with any other discount, promotion, coupon or frequent traveler program (i.e., airline frequent flyer, hotel frequency program, etc.). Local rental and age requirements apply.

Perfect Drive offers are void where prohibited by law. Perfect Drive points, frequent traveler credits/miles and Award Certificates are not exchangeable, refundable, or redeemable for cash or credit under any circumstance. Tax liabilities arising from the Perfect Drive program are the sole responsibility of the member. The Perfect Drive program offers a 100% warranty against defective products. Perfect Drive Service Center will accept any return orders for defective merchandise, with prior consent from Budget. Items returned without prior consent will not be accepted.

Budget has the right to change, limit, or modify Perfect Drive program rules, regulations, awards, and point levels at any time without notice. Budget has the right to end the Budget Perfect Drive program by provided written notice to actively participating members six months in advance. The Perfect Drive program may be suspended or terminated if events beyond Budget's control such as computer equipment or electronic data transmission failure, strikes, natural disaster, civil disturbance or war, materially affect Budget's ability to perform the Perfect Drive program.
